## How to Evaluate Furniture Needs for Your Desired Workspace Dynamics

You have the will to outfit your office with new furniture, but how do you find the way? The formula varies, but a good place to start is by soliciting feedback from those who spend 40 hours (or more) per week in the workspace. Ask questions and encourage ideas. The more information you have at your disposal, the better.

Observation is also a smart way to gauge how workers behave on a daily basis. Sure, technologies exist that can help facility managers evaluate heavy traffic areas and workflow patterns, but the eye test can fill in the gaps. How people move and use the space should educate your decisions.

Departments, teams, and individuals will have different preferences when it comes to their particular layouts. Some feel invigorated by open-floor plans and communal tables, while others require the privacy of an individualized space. That's why flexibility is the keystone to your approach.

The static office furniture of the (not-so-distant) past has a way of hampering energy and, as a result, productivity. Cubicle farms are easy targets when discussing outdated approaches to office design and employee engagement, but millions of workers who aren't confined to a cubicle are still stuck working in confined rooms that are equipped with heavy desks and insufficient light.

Opening up the space is a crucial element of designing a dynamic office. Flexible furniture helps achieve that. Yesterday's typical conference room is inefficient by design: Open a heavy wooden door to find a windowless room with a huge table in the middle, surrounded by as many chairs as can fit in the space. The door opens and shuts repeatedly while workers excuse themselves to get up and down in their seats. Time slows to a standstill. We've all been in countless meetings like that.

Today, we can create a completely new experience that's predicated on fluid movement and ease of use. Permanent walls give way to a wide-open space that can be reconfigured innumerable times with flexible varieties. That heavy conference table is replaced with a "standing" variety (42 inches tall) with a handful of stools or adjustable-height chairs in case someone wants to sit. Participants simply walk up, grab a spot at the table, and immediately get down to business. These conference tables have castors on the legs, which allow teams to flex their space in a moment's notice.

Obviously, every office situation will be unique—a building with 50 employees won't need the same elements as one with 5,000—but there's an equation to help identify what pieces are compatible. It's based on density, or how many employees per 1,000 square feet. That headcount ratio might be 5:1 or 8:1, but it gives you a base point from which to start designing. For example, if the ratio is high and the area is dense, it's sometimes ideal to have some clusters of seated desks in the blueprint in order to fill the space and account for everybody.

A lot of times, the best question to ask first is: What's more important—having everyone at the same workstation or meeting the headcount?





# Calculating the Total Cost of Office Furniture

The base price of office furniture obviously isn't the only cost involved in making a purchase. It's a mathematical equation with several variables. The total cost of ownership includes delivery, installation, future space reconfigurations, cost to business due to installation downtime or disruptions, and more.

When it comes to the initial investment itself, here are a few important factors to consider:

## Pricing

Traditional dealers utilize a line pricing and discount model that omits a lot of the costs involved with a purchase. ## Space Design

With traditional furniture, there's a lot of pressure to nail the initial space plan, and it's usually required to be set in stone months before it'll actually be installed. This can involve hiring the services of a design firm, which drives up both the cost and the time required for the project. While the resulting space may work well for your employees on Day 1, the effectiveness will decline as your business evolves and headcount is increased or decreased—which can obviously change leading right up to the install. You'll want solutions that can easily adapt over time.

## Timelines

Most design firms or dealers offer a minimum of 12-16 weeks for project completion. Consider how much can change in four months' time. Every project can experience different developments like inspection complications, permit delays, construction issues, inclement weather, and so much more. A lead time of 12-16 weeks means that furniture is ordered and scheduled for delivery long before any unforeseen delays pop up.

## Complexity of Choices and Challenges in Customization

Many of the office furniture vendors you'll discover specialize in custom options, which give you an endless array of design choices. ## Hidden Costs Furniture Buyers Often Encounter

Hiding between the lines of many office furniture invoices are unseen costs and fees that can significantly drive up your final price. Did you know:

- Many dealers charge fees for warehousing furniture if your timeline shifts. At Vari, we manage our supply chain from end to end so that there are no fees due to your timeline changing. We know that hiccups happen. Hassles don't have to accompany them.
- Traditional office furniture reconfigurations require scheduling a team of professionals for disassembly and reassembly, plus the costs of paying for labor, ordering new parts, re-carpeting or tiling if the floor was impacted, and on and on. Some traditional workstations can take eight hours to move—a full workday!—and installation crews typically charge between \$50 and \$80 per hour for labor. That means a single traditional workstation could cost between \$400 and \$640 to move, and that's not even factoring in the lost employee productivity. At Vari, we reconfigured our entire sales floor of 78 workstations within an eight-hour window, with little-to-no impact to our business operations. Typically, larger moves of 50-100 workstations take a week to execute.
- Many manufacturers address product issues by replacing parts. This requires scheduling labor to come out and diagnose the problem, ordering parts, waiting for the parts to come in, scheduling labor again, and hoping that fixes the issue. Instead of wasting your time and disrupting your business, we simply send you a brand-new product. Easy enough, right?
